"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated August 15, 2014, forwarding Resolution No. 46, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Drugs and Medicines under the Regular Budget of the Governor William 'Billy' Villegas Memorial Hospital in the amount of ₱200,000.00 to be taken from item Electricity Expenses;

"Funds having been certified as available by the Provincial Accountant per his certification dated June 10, 2014;

"On motion of Honorable Member Liland Zoila B. Estacion, seconded by Honorable Member Erwin Michael L. Macias, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 29
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Drugs and Medicines under the Regular Budget of the Governor William 'Billy' Villegas Memorial Hospital in the amount of ₱200,000.00 to be taken from item Electricity Expenses.
