(Series of 2014)



“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Repairs and Maintenance – Office Building under the current budget of the Office of the Provincial General Services Officer in the amount of ₱700,000.00 to be taken from item Janitorial Services.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2014.
