"Presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated October 20, 2014, forwarding Resolution No. 84, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for items Medical, Dental and Laboratory Supplies Expenses and Food Supplies Expenses under the Regular Budget of Bayawan District Hospital in the amount of ₱158,300.00 and ₱38,575.00, respectively, to be taken from the allocation of other MOOE items under the same office;

"Funds having been certified as available by the Provincial Accountant per his certification dated September 16, 2014;

"On motion of Honorable Member Arnolfo A. Teves, Jr., seconded by Honorable Member Erwin Michael L. Macias, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 45
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for items Medical, Dental and Laboratory Supplies Expenses and Food Supplies Expenses under the current Regular Budget of the Bayawan District Hospital in the amount of ₱158,300.00 and ₱38,575.00, respectively, to be taken from the following items:

Water Expenses	2,200.00
Electricity Expenses	77,300.00


