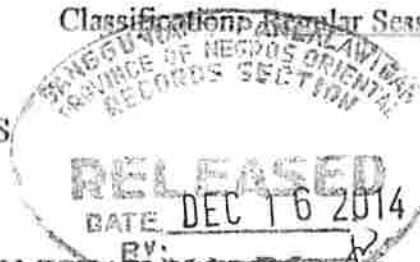

“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 7, 2014, forwarding Resolution No. 112, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Medical, Dental and Laboratory Supplies Expenses under the current hospital income budget of the Bayawan District Hospital in the amount of ₱594,737.00 to be taken from the allocation of other MOOE items under the same hospital.

“Funds having been certified as available by the Provincial Accountant per his certification dated October 28, 2014;

“On motion of Honorable Member Clayborne Clyde L. Lim, seconded by Honorable Member Arnolfo A. Teves, Jr., the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 53
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Medical, Dental and Laboratory Supplies Expenses under the current Special Account budget of the Bayawan District Hospital in the sum of ₱594,737.00, to be taken from the following items:


Electricity Expenses.....	₱ 375,000.00
Contract of Services.....	219,737.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2014.
