"Presented before the August Body for legislative authorization was Supplemental Budget No. 36 of the General Fund - Proper in the amount of ₱45,900,000.00 for the grant of Productivity Enhancement Incentive (PEI) to officials and employees of the provincial government, with the corresponding Addendum No. 41 of the Annual Investment Program for Calendar Year 2014;

"Funds having been certified as available by the Provincial Accountant per his certification dated December 5, 2014;

"On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Liland Zoila B. Estacion and Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan

"RESOLVES, To approve Addendum No. 41 of the Annual Investment Program for Calendar Year 2014, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 55
(Series of 2014)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱45,900,000.00 is hereby appropriated from the current Personal Services savings of the General Fund including devolved Hospitals for the grant of Productivity Enhancement Incentive (PEI) to one thousand five hundred thirty (1,530) officials and employees of the provincial government as provided for under Section 9.0 of Budget Circular No. 2014-3 of the Department of Budget and Management dated December 2, 2014.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
