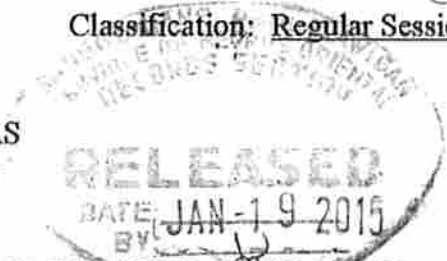

“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 28, 2014, forwarding Resolution No. 123, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Overtime & Night Pay under the current budget of the Office of the Provincial Accountant in the amount of ₱50,000.00 to be taken from item Salaries & Wages – Regular Pay;

“Funds having been certified as available by the Provincial Accountant per his certification dated October 15, 2014;

“On motion of Honorable Member Liland Zoila B. Estacion, seconded by Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 59
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Overtime & Night Pay under the current budget of the Office of the Provincial Accountant in the amount of ₱50,000.00 to be taken from item Salaries & Wages – Regular Pay.



Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2014.
