"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated December 11, 2014, forwarding Resolution No. 136, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for items Training Expenses and Office Supplies Expenses in the amount of ₱70,000.00 and ₱50,000.00, respectively, under the current budget of the Office of the Provincial Accountant, to be taken from item Traveling Expenses - Local;

"Funds having been certified as available by the Provincial Accountant per his certification dated November 18, 2014;

"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Chester V. Lim, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

**APPROPRIATION ORDINANCE NO. 60**  
**(Series of 2014)**


"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for items Training Expenses and Office Supplies Expenses under the current budget of the Office of the Provincial Accountant in the amount of ₱70,000.00 and ₱50,000.00, respectively, to be taken from item Traveling Expenses - Local.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2014.
