“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 7, 2014, forwarding Resolution No. 138-A, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Other Supplies Expenses under the current budget of the Office of the Governor in the sum of ₱105,000.00 to be taken from the allocation of other MOOE items under the same office.

“On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 67
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Other Supplies Expenses under the current budget of the Office of the Governor in the sum of ₱105,000.00 to be taken from the following items:

Repairs & Maintenance – Office Equipment.....	₱ 40,000.00
Traveling Expenses – Local.....	20,000.00
Printing and Binding Expenses.....	25,000.00
Other Maintenance and Operating Expenses.....	20,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2014.
