“Presented for legislative authorization before the August Body was Supplemental Budget No. 2 of the General Fund – 20% Economic Development Fund in the amount of ₱1,786,731.34 to fund infrastructure projects of the provincial government, with the corresponding Addendum No. 3 of the Annual Investment Program for Calendar Year 2015;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Rommel L. Erames, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution Nos. 18 and 20, both current series, of the Provincial Development Council Executive Committee, and Addendum No. 3 of the Annual Investment Program for Calendar Year 2015, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 3
(Series of 2015)

“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱350,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Multipurpose Pavement (MPP) in Sitio Balastro, Barangay Kalamtukan, Bayawan City, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated to fund the Construction of Multipurpose Pavement (MPP) in Purok II, Barangay Kalamtukan, Bayawan City.

Section 2. The amount of ₱1,436,731.34 representing existing unobligated allotment balance of the allocation for the Construction of Magatas-Calabnugan Spillway, Sibulan, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Concreting of the Calabnugan Barangay Road, Sibulan.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
