the Deployment of Bantay Gubat as Force  
Multipliers in the Protection and Enforcement  
of Forest Laws..... ₱20,000.00


Additional appropriation for the Strengthening of  
 Defense System of the Province of Negros Oriental  
 thru Deployment of SCAA's as additional  
 Security Force ..... ₱60,000.00


