Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 8

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item ‘Repairs & Maintenance-Office Equipment’ for the purchase of additional spare parts of photocopying/printing machine, under the current budget of the Office of the Provincial Assessor in the amount of ₱30,000.00, to be taken from item ‘Repairs & Maintenance-Other Machineries & Equipment’.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2015.
