“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated September 16, 2015, forwarding Resolution No. 22-A, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for various MOOE items under the current Regular Budget of the Bayawan District Hospital in the sum of ₱509,600.00 to be taken from the allocation of other MOOE items under the same hospital;

“Funds having been certified as available by the Provincial Accountant per his certification dated August 14, 2015;

“On motion of Honorable Member Peve O. Ligan, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 9  
(Series of 2015)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for various MOOE items under the current Regular Budget of the Bayawan District Hospital in the sum of ₱509,600.00, viz:

Medical, Dental & Laboratory Supplies	
Expenses.....	₱ 490,700.00
Food Supplies Expenses.....	18,900.00

to be taken from the following items:

Traveling Expenses – Local.....	₱ 40,100.00
Accountable Form Expenses.....	13,200.00

Gasoline, Oil and Lubricants Expenses.....	₱ 40,000.00
Other Supplies Expenses.....	1,500.00
Water Expenses.....	3,600.00
Electricity Expenses.....	310,150.00
Cooking Gas Expenses.....	18,890.00
Telephone Expenses – Landline.....	12,160.00
Repairs & Maint. – Motor Vehicles.....	50,000.00
Insurance Expenses.....	20,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.
