“On motion of Honorable Member Rommel L. Erames, seconded by Honorable Member Peve O. Ligan, the Sangguniang Panlalawigan

“RESOLVES, To approve Addendum No. 31 of the Annual Investment Program for Calendar Year 2015, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 21
(Series of 2015)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱3,350.45 representing current Personal Services savings under the Office of the Secretary to the Sanggunian is hereby appropriated to fund the Water Consumption and Environment and Septage Fee of same office for the period from October to December, 2014.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
