“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated October 28, 2015, forwarding Resolution No. 22-B, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item ‘Water Expenses’ under the current budget of the Office of the Provincial General Services Officer, in the amount of ₱230,000.00, to be taken from item ‘Security Services’ of same office.

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 22
(Series of 2015)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item ‘Water Expenses’ under the current budget of the Office of the Provincial General Services Officer in the amount of ₱230,000.00, to be taken from item ‘Security Services’ of same office.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2015.
