“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,049,067.00 is hereby appropriated from the Internal Revenue Allotment Differential for Fiscal Years 2001 and 2004, to fund the following:

Gulayan at Palaisdaan Alay sa Kabataan (GPAK)..... ₱ 786,799.00

Budgetary Requirement

20% Development Fund	₱ 209,814.00
30% of the 5% PDRRMF	15,736.20
70% of the 5% PDRRMF	36,717.80
