“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item ‘Water Expenses’ under the current budget of the Office of the Provincial Engineer, in the amount of ₱135,000.00, to be taken from the allocation of other MOOE items under the same office, viz:



Traveling Expenses – Local	₱ 35,000.00
Office Supplies Expenses	75,000.00
Repairs & Maint. – IT Equipment & Software	25,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.
