Section 1. The amount of ₱50,000.00 representing existing unobligated allotment balance of the allocation for Other Financial Charges under the current budget of the Provincial Treasurer’s Office, is hereby appropriated for Office Equipment (3 Units Filing Cabinet).

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
