“Whereas, presented for consideration before the August Body was the letter of Governor Roel R. Degamo dated December 9, 2015, requesting for augmentation of funds for various items under the current budget of the Office of the Provincial Treasurer in the sum of ₱122,200.00, to be taken from item Other Financial Charges of same office;

Funds having been certified as available by the Provincial Accountant per his certification dated November 23, 2015;

On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 36
(Series of 2015)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for various MOOE items under the current budget of the Office of the Provincial Treasurer to be taken from item Other Financial Charges of same office, in the sum of ₱122,200.00, viz:


Subscription Expenses	₱ 2,200.00
Financial Expenses – Bank Charges	120,000.00


Section 2. The amount of ₱2,200.00 and ₱120,000.00 shall be solely utilized for the Subscription of Newspaper and Purchase of 20,000 pieces of Customized Checks, respectively, per letter request of the Provincial Treasurer dated November 9, 2015.

Section 3. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.
