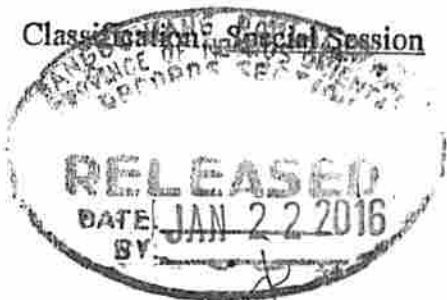

“Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator, this province, dated December 16, 2015, transmitting Resolution No. 69, current series, of the Local Finance Committee, this province, anent the request of Mr. Gregorio P. Paltinca, Provincial Agriculturist, for the augmentation of funds for item Repairs & Maintenance-Motor Vehicles under the current budget of the Government Agricultural Development Center in the amount of ₱50,000.00, to be taken from item Gasoline, Oil & Lubricants Expenses under the same center;

“Funds having been certified as available by the Provincial Accountant per his certification dated November 26, 2015;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Erwin Michael L. Macias and Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 43
(Series of 2015)


“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Repairs & Maintenance-Motor Vehicles under the current budget of the Government Agricultural Development Center in the amount of ₱50,000.00, to be taken from item Gasoline, Oil & Lubricants Expenses under the same center.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.
