Patrimonio, Provincial General Services Officer, for the augmentation of funds for item Repair & Maintenance – Motor Vehicles under the current budget of the Office of the Provincial General Services Officer in the amount of ₱250,000.00, to be taken from item Security Services of same office;

“Funds having been certified as available by the Provincial Accountant per his certification dated December 15, 2015;

“On motion of Honorable Member Rommel L. Erames, seconded by Honorable Member Liland Zoila B. Estacion and Honorable Member Peve O. Ligan, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 46  
(Series of 2015)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Repair & Maintenance – Motor Vehicles under the current budget of the Office of the Provincial General Services Officer in the amount of ₱250,000.00, to be taken from item Security Services of same office.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2015.
