"Presented for legislative authorization before the August Body was Supplemental Budget No. 43 of the General Fund Proper in the amount of ₱800,000.00 for the Terminal Leave Pay of Ms. Jocelyn P. Gongob, with the corresponding Addendum No. 45 of the Annual Investment Program for Calendar Year 2015;

"Funds having been certified as available by the Provincial Accountant per his Certification dated November 23, 2015;

"On motion of Honorable Member Jessica Jane J. Villanueva, seconded by Honorable Member Erwin Michael L. Macias and Honorable Member Rommel L. Erames, the Sangguniang Panlalawigan

"RESOLVES, To approve Addendum No. 45 of the Annual Investment Program for Calendar Year 2015, provided that the allocation for the Terminal Leave Pay of Ms. Jocelyn P. Gongob should jibe with the succeeding Appropriation Ordinance. The same is subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 47
(Series of 2015)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱664,494.17 representing Personal Services savings under the General Fund Proper is hereby appropriated for the Terminal Leave Pay of Ms. Jocelyn P. Gongob, Provincial Planning and Development Coordinator, who will be retiring from government service effective December 31, 2015.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
