“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱56,000.00 representing unobligated allotment balance from the allocation for Gasoline, Oil and Lubricants Expenses under the Office of the Secretary to the Sanggunian, is hereby appropriated for the Purchase of two (2) units Digital Handy Recorder and one (1) unit Airconditioner in the amount of ₱16,000.00 and ₱40,000.00, respectively.
