"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱ 37,551.00 representing existing allotment balance available from the allocation for item Other Property, Plant and Equipment (7611-01(00)) under the Provincial Social Welfare and Development Office is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Payment of one (1) unit Typewriter-Heavy Duty.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
