

“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱500,000.00 representing existing unobligated allotment balance of the allocation for Fresh Milk Feeding Program (LCPC) is hereby appropriated for Supplemental Feeding-Financial Assistance to Top LGUs with High Incidence of Malnutrition under the Negros Oriental Provincial Health Office at ₱50,000.00 each, to wit: Vallehermoso, Manjuyod, Sta. Catalina, Mabinay, Basay, San Jose, Bindoy, Tayasan, Bacong and Siaton.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
