"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱8,000,000.00 representing savings from item Salaries and Wages (Regular) of the General Fund including Hospitals is hereby appropriated to fund the following expenditures:

Financial Assistance to BHWs at ₱400.00/month	₱ 5,000,000.00
Financial Assistance to BPDOs at ₱400.00/month	1,000,000.00
Purchase of one (1) unit Ambulance for NOPH	1,800,000.00
Executive Legislative Agenda	200,000.00




