"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Kit Marc B. Adanza and Honorable Member Ma. Rosario F. Ocay, the Sangguniang Panlalawigan

"RESOLVES, To approve Addendum No. 6 of the Annual Investment Program for Calendar Year 2016, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 6
(Series of 2016)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱3,000,000.00 representing savings from the allocation for the following items:

Subsidy to Heart Center.....	₱ 700,000.00
Subsidy to National Kidney Institute.....	700,000.00
Subsidy to Philippine General Hospital.....	700,000.00
Subsidy to Vicente Sotto Hospital.....	900,000.00,

is hereby appropriated to fund the purchase of Laboratory Equipment for the Negros Oriental Provincial Hospital, viz:

One (1) unit Refrigerated Centrifuge.....	₱2,500,000.00
Two (2) units Centrifuge for Blood/Urine.....	500,000.00

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
