“Presented for legislative authorization before the August Body was Supplemental Budget No. 8 of the General Fund in the amount of ₱1,050,000.00 for item Food Supplies Expenses and as additional appropriation for the Purchase of one (1) unit Van under the Negros Oriental Detention and Rehabilitation Center and Sangguniang Panlalawigan, respectively, with the corresponding Addendum No. 8 of the Annual Investment Program for Calendar Year 2016;

“Funds having been certified as available by the Officer-In-Charge, Provincial Accountant’s Office, per certifications dated October 4 and 10, 2016;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Nilo D. Sayson and Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan

“RESOLVES, To approve Addendum No. 8 of the Annual Investment Program for Calendar Year 2016, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 7
(Series of 2016)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,000,000.00 representing Personal Services savings of the General Fund including Hospitals is hereby appropriated for item Food Supplies Expenses under the current budget of the Negros Oriental Detention and Rehabilitation Center for the period from November to December, 2016.

Section 2. The amount of ₱50,000.00 representing savings from the allocation for item Other Expenses – Job Order under the current budget of the Sangguniang Panlalawigan is hereby appropriated as additional appropriation for the Purchase of one (1) unit Van.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
