APPROPRIATION ORDINANCE NO. 11
(Series of 2016)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱350,000.00 is hereby appropriated from the surplus of the General Fund for Calendar Year 2015 to cover services rendered by Officiating Officials during the Governor’s Sports Festival (Multi-Sports, Water Sports and Other Events).

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
