“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Overtime and Night Pay under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱95,000.00, to be taken from item Salaries and Wages – Regular, of same hospital.
