APPROPRIATION ORDINANCE NO. 20

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱5,000,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Bagsakan Center, Barangay Villareal, Bayawan City, Negros Oriental, is hereby reverted to the



unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated to fund the following infrastructure projects:

Multi-Purpose Building, Barangay Boyco,
Bayawan City ₱ 500,000.00
- Construction of Perimeter fence at Dawis
Community Hospital, Barangay Dawis,
Bayawan City ₱1,000,000.00
