“Funds having been certified as available by the Officer-In-Charge, Provincial Accountant’s Office per certification dated December 1, 2016;

“On motion of Honorable Member Arturo V. Umbac, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 30  
(Series of 2016)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Vice Governor is hereby authorized to augment the appropriation for item Telephone Expenses – Mobile under the current budget of the Office of the Provincial Secretary in the amount of ₱4,000.00, to be taken from item Repairs and Maintenance – Motor Vehicle of same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2016.
