RESOLUTION NO. 833

"Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator, this province, dated December 8, 2016, transmitting Resolution No. 27, current series, of the Local Finance Committee, this province, anent the request of Dr. Raul L. Encarnacion, Chief of Hospital, Bayawan District Hospital, for augmentation of funds in the sum of ₱1,350,420.00 for items Medical, Dental and Laboratory Supplies Expenses and Water Expenses under the current Regular Budget of the Bayawan District Hospital to be taken from various MOOE items of same budget;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office per certification dated December 1, 2016;

"On motion of Honorable Member Kit Marc B. Adanza, seconded by Honorable Member Arturo V. Umbac, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 32
(Series of 2016)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for items Medical, Dental and Laboratory Supplies Expenses and Water Expenses under the current Regular Budget of the Bayawan District Hospital in the amount of ₱1,330,420.00 and ₱20,000.00, respectively, to be taken from other MOOE items under the same budget, to wit:


Traveling Expenses-Local	₱ 42,600.00
Gasoline, Oil and Lubricants Expenses	40,000.00


Electricity Expenses.....	600,000.00
Telephone Expenses - Landline.....	19,900.00
Other Professional Services.....	567,920.00
Repairs & Maintenance – Motor Vehicles.....	50,000.00
Insurance Expenses.....	30,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2016.
