“Whereas, presented for consideration before the August Body was the letter of the Asst. Provincial Administrator dated October 25, 2017, transmitting Resolution No. 36, current series, of the Local Finance Committee, this province, anent the request of Engr. Lilianic L. Baliola, OIC-Provincial Assessor, for augmentation of funds for item Training Expenses under the current budget of the Office of the Provincial Assessor in the amount of ₱220,000.00, to be taken from item Other Expenses – Job Order of same office.

“Funds having been certified as available by the OIC-Provincial Accountant per her certification dated September 29, 2017;

“On motion of Honorable Member Kit Marc B. Adanza, seconded by Honorable Member Georgita F. Martinez, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 47
(Series of 2017)


“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for item Training Expenses under the current budget of the Office of the Provincial Assessor in the amount of ₱220,000.00, to be taken from item Other Expenses – Job Order of same office.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2017.
