“On motion of Honorable Member Miguel L. Dungog, seconded by Honorable Member Georgita F. Martinez and Honorable Member Ma. Rosario F. Ocay, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

(Series of 2017)


“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for item Overtime & Night Pay under the current budget of the Office of the Provincial Accountant in the amount of ₱200,000.00, to be taken from item Salaries & Wages-Regular of same office.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2017.
