“Whereas, presented for consideration before the August Body was the letter of the Officer-In-Charge, Provincial Administrator dated December 4, 2017, transmitting Resolution No. 51, current series, of the Local Finance Committee, this province, anent the request of Mr. Franklin B. Culanag, OIC-Provincial Warden, this province; and requesting authority for augmentation of funds for items Food Supplies Expenses – ₱567,000.00 and Repairs & Maintenance – Transportation Equipment – ₱43,000.00 under the current budget of the Office of the Governor – Negros Oriental Detention and Rehabilitation Center, to be taken from various MOOE appropriations of same office;

“Funds having been certified as available by the OIC-Provincial Accountant per her certification dated November 9, 2017;

“On motion of Honorable Member Miguel L. Dungog, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 61  
(Series of 2017)

Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for various MOOE items under the current budget of the Office of the Governor – Negros Oriental Detention and Rehabilitation Center, in the sum of ₱610,000.00, viz:

Food Supplies Expenses.....	₱567,000.00
Repairs & Maint. – Transportation Equipment	43,000.00


Drugs and Medicines Expenses.....	₱140,000.00

Repairs & Maint. – Machinery and Equipment.....	40,000.00


