“Presented for legislative authorization before the August Body was Supplemental Budget No. 14 of the 20% Development Fund for Calendar Year 2017 in the amount of ₱980,400.20 as Additional Appropriation for the Improvement of Multipurpose Building, La Playa, Poblacion, Vallehermoso, as embodied under Resolution No. 7b, current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 14 of the Annual Investment Program for Calendar Year 2017;

“On motion of Honorable Member Jessica Jane J. Villanueva, seconded by Honorable Member Jaime L. Reyes, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution No. 7b, current series, of the Provincial Development Council Executive Committee, this province, and Addendum No. 14 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 14  
(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱980,400.20 is hereby reverted to the unappropriated balance of the 20% Development Fund representing existing unobligated allotment balance of the allocation for the Construction of Zipline from So. Mayon, Tagbino to So. Bolobangko, Ulay, Vice Versa Along the Vallehermoso to Canlaon National Road; the same amount is likewise appropriated as Additional Appropriation for the Improvement of Multipurpose Building, La Playa, Poblacion, Vallehermoso.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
