“Presented for legislative authorization before the August Body was Supplemental Budget No. 18 of the General Fund - 20% Development Fund for Calendar Year 2017 in the amount of ₱900,000.00 for the Construction of Multipurpose Building Beside the Municipal Building, Dauin, as embodied under Resolution No. 15, current series, of the Provincial Development Council, with the corresponding Addendum No. 18 of the Annual Investment Program for Calendar Year 2017;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Peve O. Ligan and Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution No. 15, current series, of the Provincial Development Council, this province, and Addendum No. 18 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 20

(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱900,000.00 representing existing unobligated allotment balance from the allocation for the project Additional Appropriation for Road Improvement of Capitan Ponso Extension, Barangay Poblacion, District II, Dauin, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of ₱900,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund for the Construction of Multipurpose Building Beside the Municipal Building, Dauin.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
