"Presented for legislative authorization before the August Body was Supplemental Budget No. 23 of the General Fund - 20% Development Fund for Calendar Year 2017 in the amount of ₱500,000.00 for the Repair and Renovation of Out-Patient Department, Bayawan District Hospital, Bayawan City, as embodied under Resolution No. 29, current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 23 of the Annual Investment Program for Calendar Year 2017;

"Funds having been certified as available by the Officer-In-Charge of the Provincial Accountant's Office per certification dated July 6, 2017;

"On motion of Honorable Member Peve O. Ligan, seconded by Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan

"RESOLVES, To approve Resolution No. 29, current series, of the Provincial Development Council Executive Committee, this province, and Addendum No. 23 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 24  
(Series of 2017)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱500,000.00 representing existing unobligated allotment balance of the allocation for the project Repair of Operating Room, Bayawan District Hospital, Bayawan City, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of ₱500,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund for the Repair and Renovation of Out-Patient Department, Bayawan District Hospital, Bayawan City.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
