Section 1. The amount of \$\mathbb{P}400,000.00\$ representing existing unobligated allotment balance of the allocation for the project Improvement of Waterworks System, Barangay Saying, Tayasan, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of \$\phi400,000.00\$ is hereby appropriated from the unappropriated balance of the 20% Development Fund for the Concreting of Barangay Road from Saying Proper to Saying Elementary School, Barangay Saying, Tayasan.
