"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Georgita F. Martinez, the Sangguniang Panlalawigan

"RESOLVES, To approve Addendum No. 20 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 32
(Series of 2017)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,500,000.00 representing Calendar Year 2016 Surplus of the General Fund Proper is hereby appropriated to fund various expenditures relative to the 2nd Agri-Livestock Fair Farm Family and BLAIDES Congress conducted by the Negros Oriental Organic Agriculture Management Council (NOOAMC), hereunder specified:

Training Expenses.....	₱975,000.00
Office Supplies Expenses.....	75,000.00
