"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office per her certification dated July 6, 2017;

"On motion of Honorable Member Ma. Rosario F. Ocay, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan

"RESOLVES, To approve Resolution No. 30, current series, of the Provincial Development Council Executive Committee, this province, and Addendum No. 24 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 33  
(Series of 2017)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱2,000,000.00 representing unobligated allotment balance of the allocation for Additional Appropriation of Footbridge, Sitio Bagtic, Barangay Enrique Villanueva, Sibulan, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Construction of Road from Crossing Tubod to Tubod-Bagtic, Barangay Enrique Villanueva, Sibulan.




