“Presented for legislative authorization before the August Body was Supplemental Budget No. 38 of the General Fund - 20% Development Fund for Calendar Year 2017 in the amount of ₱500,000.00 for the Improvement of Multipurpose Hall, Phase I, Telesforo Diao Street, Boulevard Area, Barangay Tinago, Bayawan City, as embodied under Resolution No. 24, current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 38 of the Annual Investment Program for Calendar Year 2017;

“On motion of Honorable Member Peve O. Ligan, seconded by Honorable Member Nilo D. Sayson and Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution No. 24, current series, of the Provincial Development Council Executive Committee and Addendum No. 38 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 40
(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱500,000.00 representing unobligated allotment balance of the allocation for the Construction of Multipurpose Building/ Evacuation Center, Barangay Tinago, Bayawan City, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of ₱500,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund, for the Improvement of Multipurpose Hall, Phase I, Teleforo Diaa Street, Boulevard Area, Barangay Timago, Bayawan City.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
