APPROPRIATION ORDINANCE NO. 2
(Series of 2018)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱400,000.00 and ₱900,000.00 representing existing allotment balance of the project ‘Rehabilitation and Improvement of Bunsod-Amio Provincial Road, Sta. Catalina, Negros Oriental’ and ‘Rehabilitation and Improvement of Balayong-Inawasan-Fatima-Calicanan-Amio Provincial Road, Sta. Catalina, Negros Oriental’, respectively, are hereby reverted to the unappropriated balance of the 20% Development Fund; the sum of ₱1,300,000.00 is likewise appropriated for the ‘Concreting of Barangay Road at Silfaban Street, Amio, Sta. Catalina’.
