The amount of ₱1,885,898.55 representing Personal Services savings for the period from January to May 2018 is hereby appropriated to cover the difference in compensation of personnel hired through Job Order and Contract of Services under the different offices of the provincial government, pursuant to Sangguniang Panlalawigan Resolution No. 363, current series, enacting Ordinance No. 62.
