“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱3,000,000.00 representing existing allotment balance of the allocation for the Improvement of Cangmating Camino – Vicinal Road, Sibulan, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Improvement of Agan-an Road, Sibulan, Negros Oriental.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
