"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 60  
(Series of 2018)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱452,200.00 is hereby reverted to the unappropriated balance of the General Fund representing existing allotment balance available from various projects, hereunder specified:

Blood Screening/Exams Assistance for Indigent Patients.....	₱148,200.00
Research, Monitoring, Development Activities and Project Activities.....	264,000.00
Purchase of one (1) Portable Sound System for Taclobo Science Elementary School.....	40,000.00



Section 2. The amount of ₱452,200.00 is hereby appropriated from the unappropriated balance of the General Fund to cover the following identified priority projects:


Financial Assistance for Hemodialysis Patients, 2nd District.....	₱148,200.00
Financial Assistance for Indigents in Crisis Situation.....	140,000.00
Purchase of 100 sacks NFA Rice for Various Barangays in the 2 <sup>nd</sup> District.....	150,000.00
Purchase of 4 units Ceiling Fan for Barangay Bajumpandan.....	14,000.00.
