“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱8,500,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the Grant of Productivity Enhancement Incentive to
