AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,786,083.00 FOR THE PURCHASE OF TRANSPORT/SERVICE VEHICLE FOR THE MABINAY MEDICARE COMMUNITY HOSPITAL.

“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱1,786,083.00 representing Savings from Operations of the Mabinay Medicare Community Hospital – Hospital Income is hereby appropriated for the Purchase of Transport/Service Vehicle for same hospital.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


