“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 66
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱150,000.00 FOR OTHER MACHINERIES AND EQUIPMENT – HEAVY DUTY COPIER FOR THE PROVINCIAL PLANNING AND DEVELOPMENT OFFICE.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱150,000.00 representing unexpended allocation for MOOE items under the budget of the Provincial Planning and Development Office, is hereby reverted to the unappropriated balance of the General Fund, viz:

Fuel, Oil and Lubricants Expenses.....₱80,000.00
