"Presented for legislative authorization before the August Body was Supplemental Budget No. 42 of the General Fund for Calendar Year 2019 in the amount of ₱612,556.84 for various expenditures of the provincial government;

"Whereas, one of the items of expenditure under the aforementioned budget is the Appropriation for seventeen (17) Drivers and four (4) Heavy Equipment Operators at ₱375.00/day and Engineering Assistants at ₱15,368.00/month effective October 1 to December 31, 2019, in the amount of ₱609,186.00;

"Whereas, the Provincial Engineer failed to justify the need to hire seventeen (17) Drivers and four (4) Heavy Equipment Operators;

"Whereas, to date, there are no applicants for the two (2) Engineering Assistant positions per letter dated December 12, 2019 of the Chief, Equipment Pool Division of the Provincial Engineer's Office;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office;

"On motion of Honorable Member Adem B. Maxino, seconded by Honorable Member Manuel L. Sagarbarria, the Sangguniang Panlalawigan, in session duly assembled

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱3,370.84 representing current Personal Services Savings – Salaries and Wages (Regular) - Gov. William “Billy” Villegas Memorial Hospital is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover three months Salary Differential of Ms. Mary Jean Sombrio, Laboratory Aide II of same hospital, pursuant to the Magna Carta of Public Health Workers, viz:


